Flea Market is Saturday, March 17th
Doors open to the public at 8 am & close at 3 pm

Liability: All property taken on the fairgrounds will be done so entirely at the risk of the vendor/owner. The Garrett County Agricultural Fair is not responsible for loss or damage to any property due to theft, water, dust, wind, fire or any other cause. Vendors are responsible for all transactions with the public buyers.

Set-up Hours: Set up will be held the morning of the flea market Saturday, March 11th from 5:30 am to 7:45 am. A fair board director will be available to show you your vendor space. You will be able to drive next to the building for unloading and loading of you items. Once you have unloaded your items please park you vehicle in one of our parking lots to make room for the next vendor to unload their items. You will be able to access two sides of the building so there is room for multiple vendors to unload at the same time. Make sure you have carts or dollies to easily move your items.

Tear Down: The show ends at 3 pm. Vendors must clean debris/trash from their own area after the show. There will be plenty of trashcans in the building. All you items shall be removed from the building by 5 pm.

Vendor Spaces: Each vendor space is 114sf and is \$20 each. You will have one table and two chairs. You may request multiple adjacent spaces at \$20 each. **See drawing below.** There is Wi-Fi available in the building. Electric 110v service can be provided if needed.

Prohibited Items and Inspection:

The Garrett County Fair PROHIBITS the sale or display of the following items:

- No firearms or animals to be sold at the flea market.
- No Fireworks of any kind.
- No Pornography and or other items with offensive pictures or language which is deemed inappropriate by the Garrett County Agriculture Fair Inc.
- The Fair Board has the right to ask anyone to leave if the rules are not followed.

The Garrett County Agriculture Fair reserves the right to approve all vendor material or products and to remove those that may be considered objectionable.

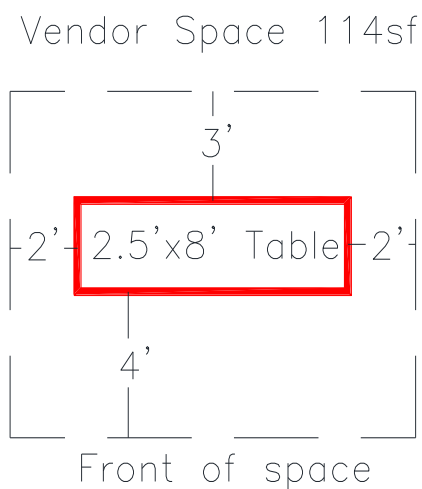
Vendors must respect all other vendors and shoppers/buyers.

The flea market spaces are reserved on a **first pay first serve basis**. Please sign and return this application / agreement along with full payment as soon as possible. Any application returned without full payment will be considered incomplete and your space may be rented to someone that has paid full price. Please make all **checks payable to the Garrett County Agriculture Fair Inc.** There will be 80 rented spaces and we will rent spaces the day of the show if available.
