Farm Queen and Court Program**

**RESPONSIBILITIES AND CODE OF CONDUCT**

**NOTE: The Garrett County Agriculture Fair, Inc. and the Garrett County Farm Bureau have formed a partnership. The person who is named Garrett County Farm Queen will represent both organizations for the period of their reign.**

- The Farm Queen and members of the court must be available on a full-time basis each day of the week of the Garrett County Fair to participate in the events associated with the Fair and at the direction and discretion of the Garrett County Fair Board of Directors.
- The Farm Queen and members of the court will conduct themselves in a manner that creates a positive reflection on themselves, the Garrett County Fair and the Garrett County Agricultural Community.
- The Farm Queen and court will be expected to restrict and refrain CELL PHONE usage while performing Farm Queen and/or Farm Queen Court responsibilities or duties.
- In addition to the week of the fair, the Farm Queen must be available to participate in a reasonable number of community events to promote the Garrett County Fair and the Garrett County Agricultural Community. (Examples include select banquets, parades, civic events, agriculturally related events, etc.)
- **The Farm Queen must also Agree to represent the Garrett County Farm Bureau at the State Farm Bureau Convention and compete in the Agricultural Ambassador competition held in December.**
- The Farm Queen and members of the court agree to dress in modest attire while participating in events and activities in an official capacity. (while wearing CROWN and SASH)
- The Farm Queen and members will **not** wear the crown and/or sash while personally competing in fair related competitions or exhibitions.
- The Farm Queen agrees to hold the title of Farm Queen exclusively during their tenure of reign.
- **As the Farm Queen or Members of the court are 4-H or FFA members, they agree to abide by any code of conduct established by those organizations.**

I have read and agree to abide by the Responsibilities and Code of Conduct established for the Garrett County Farm Queen Program. I understand that should I fail to abide by the Code of Conduct, be unable to fulfill my responsibilities, or fail to continue to meet any eligibility requirements I may be asked, and will agree to forfeit the Farm Queen (or Court) title and scholarship. I understand that the Garrett County Fair Board will determine any non-compliance with the Responsibilities, Code of Conduct and Eligibility and that any decision made by the Board in these matters will be final and not subject to appeal.
